2005 Accident Waiver and Release of Liability (Series 1)

I acknowledge that this athletic event is an extreme test of a person's physical and mental limits and carries with it the potential for death, serious injury, and property loss. The risks include, but are not limited to, those caused by terrain, facilities, temperature, weather, condition of athletes, equipment, vehicular traffic, actions of other people including, but not limited to participants, volunteers, spectators, sponsors, coaches, event officials, and event monitors, and/or producers of the event, and lack of hydration. These risks are not only inherent to athletics, but are also present for volunteers. I hereby assume all of the risks of participating and/or volunteering in this event. I realize that liability may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained or controlled by them or because of their possible liability without fault.

I certify that I am physically fit, have sufficiently trained for participation in the event and have not been advised otherwise by a medically qualified person.

I acknowledge that this Accident Waiver and Release of Liability (AWRL) form will be used by the event holders, sponsors and organizers, in which I may participate and that it will govern my actions and responsibilities at said events.

In consideration for my application and permitting me to participate in this event, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows: (A) Waive, Release and Discharge from any and all liability for my death, disability, personal injury, property damage, property theft or actions of any kind which may hereafter accrue to me or my traveling to and from this event, THE FOLLOWING ENTITIES OR PERSONS: California Bicycle Racing, their directors, officers, employers, volunteers, representatives, participants and agents, the event holders, event sponsors, event directors, event volunteers; (B) indemnify and Hold Harmless the entities as a result of any of my actions during this event.

I hereby consent to receive medical treatment which may be deemed advisable in the extent of injury, accident and/or illness during the event.

I understand that at this event or related activities, I may be photographed, I agree to allow my photo, video, or film likeness to be used for any legitimate purpose by the event holders, producers, sponsors, organizers, and/or assigns.

This AWRL shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.

FOR GOOD AND VALUABLE CONSIDERATION, including permission to participate in **VNC Racing** and related activities (“EVENT”), I, for myself, my successors, heirs, assigns, executors, administrators, spouse, and next of kin:

1. Agree that, prior to participating I will inspect the facilities, equipment, and areas to be used, and, if I believe that any of them are unsafe, I will immediately advise the person supervising the EVENT, facility, activity, or area;
2. Acknowledge that I fully understand that **my participation may involve risk of serious injury or death**, including economic losses, which may result not only from my own actions, in-actions, or negligence, but also from the actions, in-actions, or negligence of others, the condition of the facilities, equipment, or areas where EVENT or activity is being conducted, the rules of play, or this type of EVENT or activity;
3. **Assume any and all risk** of bodily injuries to myself, including medical or hospital bills, permanent or partial disability, death, and damages to my property, caused by or arising from my participation in EVENT or activity;
4. **Covenant not to sue or present any claim** for personal injury, property damage, or wrongful death against **VNC Racing** (PERMITEE/Sponsor), the City of Long Beach, their officers, employees, volunteers, and agents for damages attributable to my participation in EVENT or activity;
5. **Release, waive, discharge, and relinquish VNC Racing** (PERMITEE/Sponsor), the City of Long Beach, their officers, employees, volunteers, and agents from any liability, loss damage, claim, demand, or cause of action against them arising from or attributable to my participation in EVENT or activity, whether same shall arise by their negligence or otherwise;
6. Agree that photographs, pictures, slides, movies, or videos, of me may be taken in connection with my participation in EVENT or activity without compensation from the City of Long Beach or **VNC Racing** (PERMITEE/Sponsor), and consent to the use of these photographs, pictures, slides, movies, or videos for any legal purpose.
7. Warrant that I am in good health and have no physical condition that would prevent me from participation in this EVENT or activity; and
8. Acknowledges that the City of Long Beach or **VNC Racing** (PERMITEE/Sponsor) are not joint sponsors, joint venturers, partners, or otherwise jointly engaged in the above-named EVENT or activity.

THIS DOCUMENT RELIEVES THE CITY AND OTHERS FROM LIABILITY FOR BODILY INJURY, WRONGFUL DEATH, AND PROPERTY DAMAGE BY NEGLIGENCE. I HAVE READ THIS DOCUMENT, UNDERSTAND THAT I GIVE UP SUBSTANTIAL RIGHTS AND ASSUME ALL RISKS BY SIGNING IT, AND SIGN VOLUNTARILY.
